- Tables are numbered (numbering is continuous) and signed at the top, and
- graphic images at the bottom. All tables and images should be referenced in the
- text of the article
- The length of the article should not exceed 5 typewritten pages

# 2.1 Formatting of the title

At the beginning of the article is the title of the article (all letters capitalized, bold

font), under it is the Surname of the author and co-author(s) (bold font), scientific

supervisor(s), full name of the educational organization, country and city in nominative case, abstract and keywords in Russian and English.

# 2.2 Formatting of the main text of the article

Next follows the text of the article, which must necessarily contain the following

# 2.3 Formatting the list of references

The numbering of literature sources in the reference list is determined by the

order of their first mentioning in the text of the article, not alphabetical order.

Bibliographic references are given in Arabic numerals in square brackets.

Example: J. Kajahn et al. (2012) created in vitro simulation of the proinflammatory microenvironment of endoprostheses, which promoted monocyte differentiation in the M1 direction [50].

The nomenclature of journal titles recommended by Index Medicus (www.nlm.nih.gov) should be used in the design of the reference list. Citation by

author-date system is not allowed. In bibliographic references should be mentioned all authors (surname and after it initials with dots), in case of four or more authors, it is necessary to list the first three authors after a comma and add: "and coauthors". (et al.), and no comma should be placed before et al.

Example: Takeuchi T., Tsuboi T., Arai M. et al. Adrenergic stimulation of osteoclastogenesis mediated by expression of osteoclast differentiation factor in MC3T3-E1 osteoblast-like cells. Biochem. Pharmacol. 2001; 61(5): 579-86.

If the abbreviated name of the journal is given, dots should be put after the abbreviations; if the full name is given, dots should NOT be put after the journal name and before the year of issue of the journal. Examples: Elefteriou F. Impact of the Autonomic Nervous System on the Skeleton. Physiol. Rev. 2018; 98(3): 1083-112. Bonnet N., Gadois C., McCloskey E. et al. Protective effect of  $\beta$  blockers in postmenopausal women: influence on fractures, bone density, micro and macroarchitecture. Bone 2007; 40(5): 1209-16.

A space is needed after all punctuation except initials.

Example: Bone 2007; 40(5): 1209-16.

If several references are cited in the text, they should be given in single brackets: [11, 15, 17]

If several consecutive references are cited in the text, they should be abbreviated with a hyphen, e.g.: [11, 12, 13, 14] should be: [11-14] If there are only two consecutive references, then comma separated: [15, 16]
